



## Drain & Clean Pool - Liability Waiver

If necessary, Country Pool Service, LLC can drain & clean your swimming pool. Keep the following in mind:

- We use muriatic acid on plaster pools, chlorine on vinyl and fiberglass pools.
- We remove the pool cover and winterization plugs, if applicable.
- We remove all pressure relief plugs for hydrostatic water pressure, as the pool water is lowered.

Country Pool Service, LLC (hereinafter "we") is not responsible for pool movement due to groundwater conditions. If any permits are necessary for pumping water, securing and paying for said permits will be the pool owner's responsibility.

We will exercise every reasonable precaution to prevent water damage to your property and adjacent properties. Bear in mind, however, that it is your responsibility to consider and prepare for the potential consequences that may come from draining your swimming pool. This is especially important if your property has poor natural drainage or is in an area with limited access to city/municipal drainage.

You agree to indemnify and hold us harmless, should any damage or injury occur as a result of the draining and cleaning process, both during and after the procedure.

Note that, while we always do our absolute best to provide satisfactory services, some discoloration and rough plaster cannot always be corrected with a simple drain and clean procedure.

When the drain and clean is finished, we replace all hydrostatic plugs, then put your garden hose into the pool and start filling it with water. Once we begin refilling the pool, we will also add 2 quarts of metal remover.

When appropriate water levels have been achieved, the pool water will be tested and we will provide you with a report detailing what chemicals are necessary to balance the pool water.
