Winter Watch - 2018

Winter Maintenance Plan - Cost \$460.10 Tax Included

Winter watch includes 6 monthly visits from December 2017 to May 2018. We check: water level in pool, that the cover is secure, equipment for any damage, shock pool and add chlorine floater when needed, and that cover pumps are working properly.

If any work is needed — including water removal — labor rate is \$101.65 per hour (tax included) plus the cost of any additional materials needed.

NOTE: IF HOMEOWNER DOES NOT HAVE AN AUTOMATIC COVER PUMP TO LOWER POOL WATER, WATER REMOVAL WILL BE BILLED AT \$101.65 PER HOUR TAX INCLUDED
